## Risk Management

## Compliance

Achieving and maintaining compliance with regulatory bodies means installing required controls, auditing to ensure effectiveness, and scanning for threats to restricted classes of data, like protected health information (PHI) or cardholder data (CHD).

Though distinct, the three primary components of GRC are also all tightly interconnected.

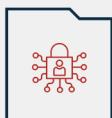
